2. MEMBERSHIP CANCELLATION:

(A) This contract may be canceled within 72 hours after signing by delivering a written notice of intent to do so. This notice must be received by the club no later than the 3rd day of signing this contract. After three days there are no refunds whatsoever and this contract remains in force.

(B) Installment Contracts may be canceled by executing a **buyout**. In order to complete the buyout the contract must be made current and all late fees paid. This contract's buyout is **\$120 primary member and/or \$60 for any dependent member(s)**. Buyout may be done by completing **Natural Fitness's Buyout Form** and paying Natural Fitness all money due it.

(C) Yearly Installment Contracts are ongoing. It is up to the Member to cancel this contract after the expiration of the terms set within this contract. Cancellation may be done by completing **Natural Fitness's Cancellation Form** and paying Natural Fitness all money due it. This form must be completed thirty or more days prior to the cancellation date. *Failure to use the facility will not relieve member of obligation of payment.
